On November 7th, 2025, at approximately 6:41 PM, while working in full uniform for the Fort Lewis College Police Department, I was performing an extra patrol in the Student Union per the request of Chief Deming. The Student Union is located at 48 E. Campus Court and 878 Rim Drive. The building has two addresses, both are on the Fort Lewis College campus, in the City of Durango, County of La Plata, and State of Colorado.

The extra patrol was requested due to a student body senate meeting regarding Turning Point USA.

The meeting was open to the public and had approximately 70 attendees in total who shared opposing political beliefs. While standing next to a group of people, I observed an elderly male in a red jacket approach a student who was booing and yelling. The male pulled out his phone and began recording the student with his phone approximately a foot away from the student's face. The male was identified as Dave Peters and the student who appears female was later identified as Megan Mollett who goes by Nova and identifies as they/them. Mollett began to strike Peters phone and hand with an empty taco bell cup after he approached with his phone in his hand.

I quickly separated the two and asked Mollett to step out of and away from the crowd. Mollett eventually complied. Around this time Chief Deming approached, and I asked him to attempt to locate Peters to ask about pressing charges. Peters was not located and believed to have left after I separated the parties.

I asked Mollett for their name to which they replied with, "I want to know if I am being charged first." I informed Mollett that per Colorado law, they are required to identify themselves when a law enforcement officer is investigating a crime. Mollett then identified themselves, and I informed Mollett they are currently not being charged with a crime. I told Mollett I understood tensions were high due to a politically motivated meeting that was happening, but they needed to take a breath and calm down. I informed Mollett they could be charged with harassment or assault due to striking Peters. After talking with Mollett, I informed her she could go back over to her group of friends, but she needed to remain calm and take a breath. After releasing Mollett, I attempted to locate Peters. I did not find him in or around the Student Union.

Mollett was semi cooperative. Body worn camera footage was preserved. That is all at this time.

On the evening of November 7th, 2025, I was working in a uniformed capacity at the Fort Lewis College Student Union Building due to an event that was occurring. The event involved the Associated Students of Fort Lewis College (ASFLC) and a second vote on accepting Turning Point as a Registered Student Organization (RSO) after a grievance was filed from the first vote the week prior denying Turning Point an RSO status. There have been high tension surrounding the Turning Point events on campus so myself and Officer Tillery were working this event. I was on scene from approximately 5:00pm that evening until approximately 8pm. After ASFLC voted allowing Turning Point as an RSO, many participants exited the Senate Chambers in the Student Union and it was obvious tensions were high in the lobby of the Student Union near the Info Desk. There were a lot raised voices and many people recoding the event on their phones.

At approximately 6:40pm following the conclusion of voting and accepting of Turning Point as an RSO, many people exited the Seante Chambers and voices were raised. Many people were filing with their phones. At one point, I observed FLC Officer Tillery escorting and individual up the walkway toward the cafeteria and it seemed as if something had occurred, although I did not witness it. I walked over the area and checked on Officer Tiller and he advised he spoke with an individual who tried to knock a cell phone out of the hands of an older male in a red jacket. Officer Tillery asked that I return to the area of the original altercation and locate the male to determine if he wanted to pursue criminal charges against the individual.

I walked back to the area but didn't immediately see the individual in question, however, I did witness another three or four individuals who were escalated so I stopped to address the behavior before a crime occurred. There was a white female approximately 45 years of age who was recording a male and female with her cell phone. She had the phone up within approximately one foot of his face and he was using his hand to block the recording, however, neither were touching one another. I advised everyone present to breathe and calm down as they gestured as if the other one was the problem. After a few minutes the group separated and I started to inquire about the older male in the red jacket. I ascertained from one individual that he had departed the building after the altercation and left. I looked outside the main doors on the west side of the building but did not see him. Due to the escalated crowd inside near the Info Desk, I remained in the area to deescalate the situation before another incident occurred. During that time, I spoke with an unidentified female who told me she knew the male in question and offered to provide me with his phone number. I advised her to have the male call if he wanted to file a police report. This concluded my involvement in this specific incident.

On November 14th, 2025, I received an email from Fort Lewis College Police Department Program Assistant Kim Angel, informing me David Peters (victim) had called our office, saying he had sent an email to Chief Deming with a statement regarding the event on November 7th, 2025. PA Angel asked me to reach out to Peters and gave me his phone number.

At 6:28 PM, I called Peters, and he stated he had emailed the statement to bdeming@flc.edu. He got the email from the Fort Lewis College Police Department website, under the department information page. All the emails for our officers on this page are incorrect. Peters also said he sent me an email. The email he sent the statement too was itillery@flc.edu, which is also incorrect.

I asked Peters if he would like to do a statement over the phone, to which he agreed. Peters stated he was not injured, and his phone was not damaged during the incident. When asked if he would like to pursue charges, he stated he would like the college to take corrective action. After getting the information needed from Peters, I continued with the statement.

Peters stated that at the end of the student senate meeting (11/7/2025), he was standing outside the meeting room in the hallway. When people started exiting the meeting, some people including himself were clapping and cheering while others were booing. He noticed a female yelling f*ck you, repeatedly. He assumed this was a student as they appeared younger. Peters estimates he was 10-15 feet away from the student who is referred to as Megan Mollett in my previous narrative. Mollett uses the pronouns they/them and prefers the name Nova over Megan. Mollett turned towards Peters and "gave him the finger" and said f*ck you again. Peters then raised his phone to take a picture of Mollett. Peters then claims Mollett took several steps closer to him and swung at him, hitting his "left" hand.

At that point I stepped in and separated the two. Peters again states he was not injured, and his phone was not damaged. Peters felt that Mollett's behavior was not appropriate for a Fort Lewis College student, followed by, "You can say whatever you want to say, but to take a swipe at somebody, weather you injure them or not is just not acceptable." I clarified if Peters wanted to pursue legal charges or have the college take disciplinary action. Peters stated he did not want to pursue charges currently and would prefer the college take disciplinary action.

I informed Peters that the disciplinary action would be up to the college and stated that our reports do get sent to the people in charge of disciplinary action and that they would see the report and his statement. If the college does not take some sort of corrective action, then Peters will consider pursuing chargers against Mollett.

After getting Peter's statement, I gave him an incident number for the report along with my correct email address. I also made sure he had our office phone number in case he needed to reach out to us with questions regarding the incident.

I activated my body camera before calling Peters and the camera died 40 seconds in to recording. I used a spare body camera to record the statement given by Peters. Both videos will be added to the body camera folder for this incident. Mollett could be charged with Harassment (CRS 18-9-111(1)(a)) which is a class 1 misdemeanor.
