Dear Ms. Nowrojee:

On September 22, 2025, President Donald Trump signed an order designating Antifa as a domestic terrorist organization. For years, Antifa terrorists have fomented and engaged in violence, ranging from nationwide riots to targeted attacks against those with whom they disagree, including conservatives, liberals, libertarians, lournalists, law-enforcement officers, pregnancy resource centers, Christian individuals, Jewish individuals, and more. Antifa's leftwing extremist violence cannot be justified. Accordingly, we write to request information about the Open Society Foundations' (OSF) financial support for organizations connected with Antifa.

According to a recent report from the Capital Research Center, since 2016, OSF has donated more than \$80 million to extremist organizations that support or engage in terrorism or other extremist violence. OSF particular concern, OSF has donated "at least \$2 million" to the Sunrise Movement, a group closely connected to Antifa. According to the Capital Research Center report, the Sunrise Movement "endorsed and solicited financial support for the Antifa-associated anarchist terrorists of the Stop Cop City / Defend the Atlanta Forest coalition" which, in 2023, violently attacked law enforcement officers and utility workers constructing a training facility near Atlanta, Georgia for police officers and firefighters. During the siege, Antifa terrorists threw Molotov cocktails, bricks, and rocks at law enforcement officers, attempted to blind officers by shining lasers in their eyes, and set construction equipment and a police car on fire, among numerous other violent acts. A Prosecutors later charged more than 40 individuals with domestic terrorism due to the attacks.

OSF has complained—without a hint of irony¹⁶—that criticism of its financial support for terrorists threatens its freedom of speech.¹⁷ Of course, OSF is wrong; providing material support for terrorists is not protected by the First Amendment.¹⁸ Moreover, according to one free speech scholar, "Antifa was expressly founded as a movement at war with free speech," and it considers violence to be a necessary tool for waging its "war."¹⁹

Congress has an important interest in protecting Americans from political violence. As part of the Committee's oversight, we respectfully request that you provide the following documents and information:

- 1. All documents and communications referring or relating to the Sunrise Movement or Antifa, including local Antifa groups such as Atlanta Antifa,²⁰ from January 1, 2019, to the present;
- 2. All documents and communications referring or relating to any grants, donations, or other financial contributions OSF provided to the Sunrise Movement from January 1, 2019, to the present;
- 3. All documents and communications referring or relating to OSF's awareness of any act of violence or other criminal activity conducted by individuals associated with organizations to which OSF provides material support; and
- 4. All documents and communications referring or relating to OSF's efforts, if any, to ensure its grant recipients are not engaging in or promoting political violence.

Please produce all documents and information as soon as possible but no later than 5:00 p.m. on November 20, 2025.

This letter serves as a formal request to preserve all existing and future records and materials relating to the topics addressed in this letter. You should construe this preservation notice as an instruction to take all reasonable steps to prevent the destruction or alteration, whether intentionally or negligently, of all documents, communications, and other information, including electronic information and metadata, that are or may be responsive to this congressional inquiry. This instruction includes all electronic messages sent using your professional and personal accounts or devices, including records created using text messages, phone-based message applications, or encryption software.

The Supreme Court has recognized that Congress has a "broad and indispensable" power to conduct oversight, which "encompasses inquiries into the administration of existing laws, studies of proposed laws, and surveys in our social, economic or political system for the purpose of enabling Congress to remedy them." Pursuant to the Rules of the House of Representatives, the Committee on the Judiciary is authorized to conduct oversight of matters concerning criminal law to inform potential legislative reforms. ²²
