11/28/2025: This process server arrived at the designated location at 10:09 AM. A SUV vehicle was present in the driveway, which was observed to be running upon approach. The windows of the aforementioned vehicle were heavily tinted, making it difficult to determine if there were any occupants inside. A "Posted No Trespassing" sign was posted in the front of the residence. One pick up truck on side of driveway.

Proceeding to the front entrance, this process server noted the presence of a "Ring" doorbell/camera. An initial knock on the door yielded no response, followed by activation of the Ring device, again with no answer. After waiting several minutes, this server returned to her vehicle. While passing the running vehicle in the driveway, she inspected both the front and driver's side windows and knocked to ascertain occupancy; the vehicle did not appear to be occupied. This process server contacted her supervisor and provided the license plate information from the vehicle present (FL Tag: Records indicate the vehicle is registered to the witness, CHRISTOPHER PURCELL KEPNER, at the given address. While stationed at the street, this process server observed the SUV's lights and horn activate, as though it was being remotely locked.

This process server then returned to the front door. Once more, the SUV was checked for occupants, but none were observed. Additional knocks and use of the doorbell also received no answer. The process server identified herself audibly as a Process Server, clarifying that she was neither press nor law enforcement, and displayed her identification badge for the camera while stepping back to ensure visibility from within the home. No response was forthcoming. She knocked and rang the bell once more, announcing she had a subpoena for Christopher Kepner, specifying an appearance date of December 5, 2025. At 10:29 AM, this process server left the subpoena under the windshield wiper ofthe named witnesses SUV, which remained running in the driveway.

This process server subsequently departed the premises. Upon returning at 11:07 AM, she noted that the SUV was no longer present. A search of the yard and street revealed that the subpoena was not found.
