**A BILL**

To designate the area of 16th Street Northwest between H Street Northwest and K Street Northwest in the District of Columbia as the “Charlie Kirk Freedom of Speech Plaza”, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Charlie Kirk Freedom  
5       of Speech Plaza Act”.



1 **SEC. 2. DESIGNATION OF CHARLIE KIRK FREEDOM OF**  
2 **SPEECH PLAZA.**

3 (a) DESIGNATION OF PLAZA.—

4 (1) IN GENERAL.—The area of 16th Street  
5 Northwest between H Street Northwest and K  
6 Street Northwest in the District of Columbia (for-  
7 merly symbolically designated as “Black Lives Mat-  
8 ter Plaza” under the Black Lives Matter Plaza Des-  
9 ignation Act of 2020 (sec. 9–204.01 note, D.C. Offi-  
10 cial Code), shall be known and designated as “Char-  
11 lie Kirk Freedom of Speech Plaza”.

12 (2) REFERENCES.—Any reference in a law,  
13 map, regulation, document, paper, or other record of  
14 the United States to the area referred to in para-  
15 graph (1) shall be deemed to be a reference to  
16 “Charlie Kirk Freedom of Speech Plaza”.

17 (b) SIGNS.—

18 (1) CONSTRUCTION.—The District of Columbia  
19 shall construct not less than 2 street signs that  
20 shall—

21 (A) contain the phrase “Charlie Kirk Free-  
22 dom of Speech Plaza”; and

23 (B) be similar in design to the signs used  
24 by the District of Columbia to designate the lo-  
25 cation of Metro stations.



1           (2) PLACEMENT.—Not later than 90 days after  
2           the date of the enactment of this Act, the District  
3           of Columbia shall place the signs constructed under  
4           paragraph (1) above existing signs at the intersec-  
5           tion of 16th Street Northwest and H Street North-  
6           west and the intersection of 16th Street Northwest  
7           and K Street Northwest.
