THIS DEPUTY RESPONDED TO MIAMI INTERNATIONAL AIRPORT REFERENCE A BATTERY BETWEEN PASSENGERS ON FRONTIER FLIGHT 2089 FROM SAN JUAN TO ATLANTA.





