Probable Cause

Before Me, the undersigned authority personally appeared DEPUTY [REDACTED] who being duly sworn, alleges, on information and belief, that on the 27TH day of MARCH 2026 in Marion County, Florida the defendant did:

Commit the offense of GRAND THEFT MORE THAN \$750 LESS THAN \$5,000, DEALING IN STOLEN PROPERTY to wit:

ON 03/27/2026, I RESPONDED TO [REDACTED] SUMMERFIELD, MARION COUNTY, FL, IN REFERENCE TO A STOLEN WASHER AND DRYER.

CONTACT WAS MADE WITH THE VICTIM, DENISE LOMBARDI , VIA CELL PHONE, WHO ADVISED SHE HAS A SQUATTER STAYING IN THE HOME WHO WAS RECENTLY SERVED A NOTICE TO VACATE. THE VICTIM ADVISED THE SQUATTER, THE DEFENDANT CANDICE MACKEY, HAS TO VACATE THE RESIDENCE ON 03/31/2026. THE VICTIM ADVISED SHE RECEIVED A CALL FROM A NEIGHBOR ADVISING THE DEFENDANT HAD SOLD THE FRIGIDAIRE WASHER AND DRYER THAT BELONGS IN THE RESIDENCE TO ANOTHER NEIGHBOR. THE VICTIM ADVISED ME THAT THE DEFENDANT WAS ARRESTED FROM THE HOUSE IN DECEMBER. THE VICTIM ADVISED THE DEFENDANT WAS NEVER WELCOMED TO THE HOME BY HER NOR ALLOWED TO STAY THERE. THE VICTIM ADVISED SHE RESPONDED TO THE RESIDENCE A COUPLE OF MONTHS AGO AND REALIZED THE DEFENDANT WAS STAYING IN THE RESIDENCE. THE VICTIM DID NOT KNOW WHO THE DEFENDANT WAS AND REALIZED THE DEFENDANT HAD BEEN STAYING IN THE RESIDENCE SINCE DECEMBER DUE TO HER NEPHEW, 'JAMES', INVITING THE DEFENDANT TO STAY THERE. THE VICTIM ADVISED THE DEFENDANT DOES NOT OWN THE APPLIANCES IN THE HOUSE, THE APPLIANCES CAME WITH THE HOUSE WHEN SHE RENTED IT TO HER NEPHEW.

THE VICTIM ADVISED WHEN HER NEPHEW 'JAMES' MOVED IN THE WASHER AND DRYER WERE ALREADY IN THE RESIDENCE AND WERE TO STAY IN THE RESIDENCE.

UPON ARRIVAL, CONTACT WAS MADE WITH THE NEIGHBOR, PEDRO SANTANA RIOS, WHO RESIDES AT [REDACTED]. HE ADVISED HIS WASHER AND DRYER STOPPER WORKING AT HIS RESIDENCE. HE ADVISED HE NOTICED THE DEFENDANT WAS MOVING OUT OF THE INCIDENT LOCATION AND SHE OFFERED TO SELL HIM THE WASHER AND DRYER. THE DEFENDANT THEN SOLD HIM A WHITE FRIGIDAIRE WASHER AND DRYER SET FOR \$150.00. MR. SANTANA RIOS ADVISED ONCE HE FOUND OUT THE DEFENDANT DID NOT OWN THE WASHER AND DRYER HE ATTEMPTED TO RETURN IT AND GET HIS MONEY BACK. MR. SANTANA RIOS ADVISED THE DEFENDANT THEN TOLD HIM SHE WOULD NOT TAKE THE WASHER AND DRYER BACK AND WOULD NOT GIVE HIM HIS MONEY BACK. MR. SANTANA RIOS THEN SHOWED ME THE WASHER AND DRYER. THE VICTIM PROVIDED ME A PICTURE OF THE WASHER AND DRYER THAT SHE OWNS AND THEY WERE THE SAME WASHER AND DRYER WITH THE SAME MARKINGS AND DAMAGE TO THEM.

THE VICTIM ADVISED THE WASHER AND DRYER COST A TOTAL OF \$1,800.00.

CONTACT WAS MADE WITH THE NEIGHBOR, WITNESS DENISE MACLEAN, WHO RESIDES AT [REDACTED]. SHE ADVISED SHE HAS BEEN FRIENDS WITH THE VICTIM'S MOTHER FOR OVER 20 YEARS. THE WITNESS ADVISED THE VICTIM'S MOTHER AND AUNT USED TO STAY IN THE INCIDENT LOCATION IN WHICH THE VICTIM VISITED REGULARLY. THE WITNESS STATED PRIOR TO THE DEFENDANT MOVING INTO THE RESIDENCE, THE SAME WASHER AND DRYER SOLD TO MR. SANTANA RIOS WERE THE WASHER AND DRYER SHE OBSERVED INSIDE THE INCIDENT LOCATION. THE WITNESS ADVISED MR. SANTANA RIOS SHOWED HER THE WASHER AND DRYER AND SHE ALSO WAS ABLE TO IDENTIFY THEM THROUGH A PICTURE I SHOWED TO HER. THE WITNESS ALSO ADVISED APPROXIMATELY A YEAR AGO SHE WENT TO THE INCIDENT LOCATION TO USE THE WASHER AND DRYER DUE TO HERS BEING BOKEN. THE WITNESS ADVISED THE RENTER AT THE TIME (VICTIM'S NEPHEW JAMES) ALLOWED HER IN TO USE THE WASHER AND DRYER. THE WITNESS IDENTIFIED THE WASHER AND DRYER AS THE SAME SOLD TO MR. SANTANA RIOS.

CONTACT WAS THEN MADE WITH THE DEFENDANT. POST MIRANDA WARNINGS THE DEFENDANT ADVISED SHE BOUGHT THE WASHER AND DRYER ONCE SHE WAS RELEASED FROM JAIL. IT SHOULD BE NOTED THE DEFENDANT WAS IN MARION COUNTY CUSTODY IN DECEMBER OF 2025. THE DEFENDANT ADVISED SHE BOUGHT THE WASHER AND DRYER AT THE BEGINNING OF 2026, SHE THEN ADVISED SHE BOUGHT THE WASHER AND DRYER IN NOVEMBER OR OCTOBER OF 2025, THEN CAME TO THE CONCLUSION SHE BOUGHT THE WASHER AND DRYER IN SEPTEMBER OF 2025. THE DEFENDANT ADVISED SHE BOUGHT THE WASHER AND DRYER FROM AND UNIDENTIFIED AMBER SUBJECT, WHO THE DEFENDANT ALLEGED STOLE THE WASHER AND DRYER OUT OF THE INCIDENT LOCATION, AND WAS BEING SOLD OUT OF A SHED DOWN THE STREET. THE DEFENDANT ADVISED SHE COULD
