NARRATIVE

Incident Type: Domestic Assault

Incident Number: 15-1952

Date, Time, and Venue: Occurred on 02-01-2015 at 01:05hrs at [REDACTED] in the City of Kentwood, County of Kent.

Summary: Brian Hooker stated he was assaulted by his wife Lynette Hooker. He said he was struck in the face multiple times. He had injuries and refused medical.

Dispatch: Dispatched to a intoxicated female locked in a upstairs bedroom. Female stated she was assaulted by someone in the home.

Arrival: Ofc Vanderbent and I arrived on scene and made contact with Brian Hooker on the main floor of the home. He was intoxicated and had blood coming from his nose.

Contact with victim Brian Hooker: He stated he got stuck in the face several time by his wife. He stated she was drunk and thought [REDACTED] and a [REDACTED] [REDACTED] were locked in a room upstairs "fooling around". He stated Lynette attempted to open the door. Brain Hooker stated he went upstairs to calm her down and Lynette Hooker struck him in the face 4 to 5 times. He stated he had never been hit like that in a long time. He started to cry and became emotional.

Contact with witness [REDACTED] She stated she heard Lynette upstairs causing a commotion. She stated Brian went upstairs and returned several minutes later. He was bleeding from the nose.

Contact with Suspect Lynette Hooker: She was upstairs talking with dispatch. She was highly intoxicated. I brought her downstairs and asked her what occurred. She stated she was struck in the forehead by her husband Brian. She stated her kids had locked themselves in a room upstairs she was attempting to get in when she was assaulted by Brian. She stated he choked her and punched her once.

Injuries: Brian Hooker had a bloody nose that was red and swollen. He refused medical. Lynette Hooker had no visible injuries. I did not observe any marks or scratches on her. She refused medical.

Attempt contact with [REDACTED] and [REDACTED]: I was advised that both had left the home together due to the incident. I attempted contact with both via telephone. No answer. No one stated they were involved in an assault but they may have witnessed it.
