The event occurred on 07/10/2025 at approximately 17:53 at 1699 STATE PLACE NW, WASHINGTON, DC 20006.

The event occurred on Thursday July 10, 2025, at approximately 17:26 hours at 1699 State Place NW Washington DC.

Ofc. Vargas #0361(AS-1) in full police uniform was working at a pedestrian access control post at the White House when he observed S-1 (later identified by word of mouth as Nasire Best 09/26/2004) walk into a restricted area by using the exit turnstile lane located at the post AS-1 was stationed at. The restricted area has multiple signs posted stating "Do Not Enter Exit Only, Police Line Do Not Cross, Pass Holders & Appointments Only". AS-1 immediately told S-1 to stop, S-1 did not listen to the verbal commands from AS-1 and did not stop and continued to go further into the restricted area. Ofc. Gochar #3421(AS-2) arrived to assist AS-1, AS-1 and AS-2 detained S-1. MPDC Officers Buerster #4887 and Cartagena #3149 arrived on scene and had their body worn cameras on at the time of the incident.

Ofc. S. Murray #3206 (AO) and Ofc. Moore #2698 (AS-3) arrived on scene to assist. An NCIC check of S-1 came back clear, no wants, no warrants. S-1 claimed he was Jesus Christ and that he wanted to get arrested. A check of the appointments and passholders database returned that he did not have an appointment or authorization to enter the White House complex. S-1 is known to United States Secret Service (USSS) for walking around the White House complex inquiring how to gain access at various entry posts. S-1 was involuntary committed on June 26th, 2025 by (USSS) for obstructing vehicle entry to the White House complex at 15th Street and E street, NW.

S-1, now D-1 was placed under arrest for Unlawful Entry. AS-3 and Ofc. Chambers #2944 (AS-4) conducted a search incident to arrest on D-1.

Ofc. Santos #2856(TO) arrived on scene and transported D-1 to MPD 2nd District for processing.

AO is requesting a White House Stay Away order for D-1 with the parameters of 18th Street NW, I Street NW, 14th Street NW, Constitution Avenue NW.

The event and acts described above occurred primarily in the District of Columbia and were committed as described by defendant(s) listed in the case caption.
