 Before Me, the undersigned authority personally appeared Det. M. Graham 3456 who being duly sworn, alleges, on information and belief, that on the 19th day of June, 2026 in LAKE County, Florida, the defendant did:

On June 19, 2026, your Affiant was contacted by Detective Hernandez of the Leesburg Police Department in reference to an active investigation involving digital voyeurism. Det. Hernandez informed your Affiant that part of the violations discovered during his investigation occurred within the jurisdiction of the Lake County Sheriff's Office.

Det. Hernandez provided your Affiant with the following details involving his investigation:

"On 06-19-2026, Cpl. Navarro responded to the Leesburg Police Department at 115 E. Magnolia St, Leesburg, Lake County FL in reference to a walk-in reporting possible child pornography. Due to the case involving child pornography the Leesburg PD Criminal Investigations was contacted. I was requested to assist with the investigation.

I spoke with Cpl. Navarro, who advised that he was with a RoMac employee, who was the Director of Information Technology (IT) Department of RoMac Building Supply. The director stated that during a computer upgrade process he copied the local files to Google drive and transferred ownership of the new computer to who he identified as Bart Lucas. The director stated as he was looking through the recent files on the drive and noticed photos of people in an inappropriate manner. The director stated he scrolled through pictures and observed what appeared to be topless adolescent girls and upskirt style photos of adolescent girls as well. The director stated that Bart had sole access to the computer other than IT if needed. The director also advised that Bart's account is password protected and is only available to Bart.

Before Me, the undersigned authority personally appeared Det. M. Graham 3456 who being duly sworn, alleges, on information and belief, that on the 19th day of June, 2026, in LAKE County, Florida, the defendant did:

Also, the director stated that Bart requested to take the computer home after the IT department had changed his computer. The computer change occurred on approximately April 2026. On 06-17-2026, while doing other work, the director inadvertently came across the suspicious files.

Cpl. Navarro queried the provided suspect name to the Leesburg Police Department Communications Center and was advised there was a male in-house with the name of, Charles Barton Lucas, with the same date of birth and similar name.

While speaking to the director he made contact with the RoMac Human Resources (HR) Manager via phone call. Cpl. Navarro and I spoke to the HR Manager via this phone call where he identified "Bart" as Charles Lucas (DOB 08-27-1966) and provided his SSN. The HR Manager also provided Mr. Lucas's email address to be Mrbartman87@yahoo.com and phone number to be 352-267-6702. Cpl. Navarro then provided the LPD Communications Center with the information and was advised it was the same male that was in the LPD in-house system.

The director came into LPD with the computer tower that had been changed out, that had been previously assigned to Mr. Lucas that contained the files he had advised officers about.

A Leesburg Police Department consent to search electronic media, computers, computer peripherals and related media form was completed and signed by the director as the representative of RoMac.

As the tower was plugged in and turned on, the name Bart Lucas, showed up on the power-up home screen with a pin password. The director stated he knew Bart's password to be [REDACTED]. The director then stated the route he took to view the suspicious files/photographs were [REDACTED]. Upon arriving there, there were multiple photos, screen shots and PDF files. As I scrolled down, there were multiple photos of topless pubescent photographs of what clearly were white females. There were also upskirt style photos of unidentified juveniles and possible adult females. The photographs appeared to mostly be "screenshots" taken on the computer. Many of these were zoomed in to focus on the vaginal region of clearly juvenile children, who were either wearing tight bike short type clothing or were in a position that exposed their underwear. There was also a significant number of screenshots photographs depicting children where the focus of the image was up or down the child's shirt. Additional photos and videos depicting the same material were located in the Recycle Bin as well.

Before Me, the undersigned authority personally appeared Det. M. Graham 3456 who being duly sworn, alleges, on information and belief, that on the 19th day of June, 2026, in LAKE County, Florida, the defendant did:

The director and assistant manager advised that Bart's new computer is a laptop that could be taken home (Bart's personal residence). The assistant manager stated that Bart had access to the Google Drive via the laptop but it could also be accessed by any electronic device that had an internet connection. The assistant manager stated that Bart would simply use the login information for the Google Drive on any other electronic device with internet access and all the files would be readily available to be modified, transferred, or deleted.

Charles B. Lucas was positively identified via his FL DL online photograph where his SSN is also the same provided by the HR manager.

All files were downloaded to an external hard drive provided by CID of LPD. The PC tower was also collected and will be placed in a secure evidence locker at the Leesburg Police Department."

Your Affiant responded to the Leesburg Police Department and reviewed the aforementioned media collect from work computer and Google Drive. During review of the media, your Affiant observed and confirmed details provided by Det. Hernandez.

During your Affiant's review of the file titled "[REDACTED]" he observed a white female dressed in dark clothing, disrobe within view of the recording device. While disrobing the white female's breasts and vaginal area are visible. The white female's hair appears to be damp and she is using a towel to dry her skin. There is a timestamp of "[REDACTED]" in the lower right corner of the recording

During your Affiant's review of the file titled "[REDACTED]" he observed a white female appearing to be middle aged, pull her bottoms down to sit on top of a toilet. The white female's vagina area and pubic hair are visible in the video.

During your Affiant's review of the file titled "[REDACTED]" he observed a white female wearing a green t-shirt and black bottoms, pull her bottoms down and sit on top of a toilet. The white female's vagina area and pubic hair are visible in the recording. Based on your Affiant's training and experience appeared to be less than 16 years of age.

During your Affiant's review of the file titled "[REDACTED]" he observed a white female enter view of the recording device accompanied by an older white female. The younger white female disrobes causing her breast to be fully visible. There is a timestamp of "[REDACTED]" visible in the lower right corner of the recording.

During your Affiant's review of the file titled "[REDACTED]" a white female dressed in black clothing, pull her pants and underwear down and sit on top of a toilet. The white female urinates, pulls her pants up and leave view of the video. The white female's vaginal area is in view during the video.

On June 19, 2026 the Defendant Charles Lucas was taken into custody and transported to LCJ without incident.
