Count 1) PC187(a)

COUNT 1 – MURDER

The undersigned states, on information and belief, that Marcos Eduardo Iriarte-Valdez, Defendant, did commit a Felony, a violation of PC187(a), Murder, committed as follows:

On or about August 6, 2026, in the County of Contra Costa, State of California, the crime of Murder in violation of PC187(a), a Felony, was committed in that MARCOS EDUARDO IRIARTE-VALDEZ did unlawfully, and with malice aforethought murder Todd Stewart, a human being.

ENHANCEMENT 1

PC190.2(a)(17): Special Allegation - Felony Murder - Burglary

It is further alleged as to Count 1 that the murder of Todd Stewart was committed by defendant, MARCOS EDUARDO IRIARTE-VALDEZ while the said defendant, MARCOS EDUARDO IRIARTE-VALDEZ was engaged in immediate flight after having committed and attempted to commit, engaged in the attempted commission of and engaged in the commission of the crime of burglary in the first and second degree in violation of Section 460, within the meaning of Penal Code Section 190.2(a)(17).

ENHANCEMENT 2

PC12022(b)(1): Special Allegation-Use Of Deadly Weapon

It is further alleged as to Count 1 that in the commission and attempted commission of the above offense, the said defendant, MARCOS EDUARDO IRIARTE-VALDEZ, personally used a deadly and dangerous weapon(s), to wit, Knife, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).

ENHANCEMENT 3

PC12022.1: Special Allegation-Offense While On Bail Or O.R.

It is further alleged as to Count 1 that at the time of the commission of the above offense, the defendant, MARCOS EDUARDO IRIARTE-VALDEZ, was released from custody on bail or Own Recognizance in Case Number 01-26-02467 within the meaning of Penal Code section 12022.1.

Complainant requests that the Defendant[s] be dealt with according to the law.
