The Affiant, Detective Sullivan, being first sworn, says there is probable cause to believe the defendant, Jobe Binkley, committed an offense based on the summary of facts below:

Your Honor,

On Friday August 21st, 2026 Officer Fleming, while working as an agent of the U. S. Marshal's Office, responded to 1436 W. North Street, Springfield Ohio, Clark County. He was assigned a case where the child victim was an entered missing person and this was the last known address that they were believed to be at.

He spoke with the resident owner, Jobe Binkley, who stated the juvenile was inside. He called for the juvenile and they exited the home. Officers had been to Mr. Binkley's house on two previous occasions where the juvenile was entered missing. At those times he refused officers to enter his home and stated that the missing person was not inside. Officers noted that Jobe was made aware the individual was in fact an active missing person.

At this time I am requesting a warrant on Jobe Binkley for one count of interference with custody.
