2. The facts supporting this belief are as follows: On or about September 5, 2026, officers responded to a shooting at or near the Jimmy John's located at 3822 Laclede Ave.

Victims 1, 2, and 3 had relocated from the scene of the shooting due to safety concerns.

Through my investigation, I learned that the Defendant, an employee of Jimmy Johns, got into a verbal argument with Victim 2, a former employee of Jimmy Johns. This argument carried into the parking lot where the Defendant and Victim were still arguing.

Victim 1, who is Victim 2's boyfriend was present for the argument in addition to Victim 3, who is Victim 2's juvenile daughter.

Victim 2 got into a vehicle with her boyfriend, Victim 1, and juvenile daughter, Victim 3. As they drove off, the Defendant fired multiple rounds into the rear of the vehicle. Victim 3, the juvenile, was struck by one of the bullets in her left leg.

Subsequent examination of the victim's vehicle revealed ballistic damage to the trunk.

When I had arrived on scene, the Defendant had already fled, but later returned and was driven by his friend. The Defendant was taken into custody.

While in custody, the Defendant was read his Miranda rights. Post Miranda, the Defendant admitted to firing at the vehicle.

When asked where the firearm was now, the Defendant advised he left it at his house.
